

INFORMATIVE FORM OF PROCESSING OF PERSONAL DATA AND

DECLARATION OF CONSENT



Regulation no. 2016/679 (EU) of the European Council and of the Council of 27th of April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data entered into force on 25th of May 2018 throughout the European Union (**General Data Protection Regulation**, also known as **GDPR**).

Record keeping and processing of personal data related to the Company's customers and operators comes as a result of our total compliance with the requirements of the Processing of Personal Data Laws, as they have been amended and currently apply and aims at the best possible service of our customers and their demands, the more effective protection of their interests, their provision of information with regard to any opportunity/offer for lease or sale/purchase of real estate, the sufficient provision of services offered by the Company and the quicker handling of the work, which is delegated to the Company.

We process your personal data for the duration of our contract, by other words, in the case of assignment of sale of real estate until it is sold and transferred and in the case of assignment of lease of real estate until it is leased. After the termination or cancellation of the contract, we will continue processing those data which are necessary for statistical purposes, protecting at the same time your rights and freedoms, the necessary data in order to comply with our obligations, under the legislation and for as long as it is required and also the necessary data in order to protect our legal rights for as long as it is required. In case of any start of court proceedings, related directly or indirectly to the undersigned individual, the mentioned period of maintenance of the data will be suspended, throughout the duration of the proceedings, until the adoption of the final judgment, thus continuing until the completion of the 20 year limitation period.

As a customer of the Company, I positively declare that I was informed of the exact purposes of the processing, made by electronic or non-electronic means, of personal data which concern me, the kind of data

that are being processed, the persons in charge of processing and also the recipients of the data and I provide my unconditional consent to the above processing. I also declare that I accept any message sending by e-mail to my stated personal e-mail address, or by any other mean of communication, relating to sale/lease of real estate and any other subject that concerns me. I am sufficiently aware of my right of access to the above data, the right of objection to the processing and also the right of revocation of my consent at any time.
